To qualify, the organization(s) must have tax exempt status under paragraph "3" of subsection "c" under section 501 of the US Internal Revenue Code of 1954 - 501(c)(3). The organization(s) must be providing health and human care services in Alaska. Churches, religious programs, educational institutions and foundations, cultural groups, service clubs, legal defense funds and political organizations are not eligible. All designated funds less a 13% designation processing fee are passed on to the designated organization(s) separate from other funding from United Way of Anchorage. Donor must provide legible name and city of organization(s). United Way of Anchorage charges no fee to United Ways in Alaska.
