Official Rules for 2018 United Way of Anchorage Win/Win 2019 Chevrolet Trax Sweepstakes



Donors will automatically be entered to win the sweepstakes if their gift meets the following criteria:

1. Annual gift to United Way, State of Alaska Employee Charitable Campaign (SHARE), Municipal Employee Fundraising Campaign (MEFC), Anchorage School District Charitable Giving Campaign (ASD) is increased by any amount from 2017 or is a first-time gift of at least \$52 (\$1 per week), and
2. Gift is made using a United Way of Anchorage pledge form, or the shared "Statewide" pledge form, or the SHARE or ASD pledge form or via an electronic pledge system that includes the sweepstakes information, and
3. Pledge form or electronic information is submitted to United Way of Anchorage by 4:00 p.m. December 7, 2018.

Donors who live in Anchorage or who work for a company based in Anchorage, whose gift meets criteria #1 but who give via a company pledge form (paper or electronic) that does not include the sweepstakes information or via system from which data will not be made available to UWA by December 7, 2018, may complete an alternate entry form to enter the sweepstakes. Alternate entry forms are available from the company employee campaign coordinators or from the United Way of Anchorage office.

Sweepstakes will commence on Feb 7, 2018. To qualify, all sweepstakes entry forms or data must be received by 4:00 pm on December 7, 2018 at 701 West 8th Avenue, Suite 230, Anchorage, Alaska 99501.

No donation is necessary to enter or win. A donation will not increase the chances of winning. A manual entry form will be available during the sweepstakes by sending a request and a self-addressed stamped envelope to United Way of Anchorage "Win/Win 2019 Chevrolet Trax" Sweepstakes, 701 West 8th Avenue, Suite 230, Anchorage, Alaska 99501. Entrants must have their principal residence or their principal place of employment in Alaska.

Limit one entry per person.

The odds of winning shall be determined based upon the number of valid entries received.

Sweepstakes void where prohibited or restricted by law.

Illegible entries will be disqualified.

All prize-winners must meet the following qualifications:

- Be at least 18 years of age on or before February 1, 2019. Winner must provide proof of age.
- The winner will be required to sign a Waiver Sheet/Release Form, provide his/her social security number, and claim prize within ten (10) days of notification.
- The winner releases United Way of Anchorage, subsidiaries, suppliers, advertisers and promotion agencies, respective employers and agents from any and all liability arising out of participation in this game.
- The acceptance of a prize constitutes permission to use the winner's name or likeness for the purpose of advertising, promotion and trade in connection with United Way of Anchorage without further compensations.
- The prize cannot be transferred or redeemed for cash.

United Way of Anchorage and other contest sweepstakes sponsors are not responsible for lost, late, misdirected mail or entries not forwarded to United Way by the close of the sweepstakes.

Before the second week of February 2019, 5 finalists will be randomly drawn from all eligible entries received by 4:00 p.m. December 7, 2018. Finalists will be announced by the second week in February 2019. Each finalist will be required to attend the Chevrolet Trax Sweepstakes finale at Alaska Sales and Services on DATE TBD. **Must be present to win.** If finalist is unable to attend the event, another finalist will be selected.

In addition to the 5 finalists, 25 additional names will be randomly drawn from all eligible entries to participate in the "Wild Card" drawing. These 25 people must be present at the finale to be eligible to win. No proxy's will be allowed. One of them will be chosen in the "Wild Card" drawing on site to participate as the sixth participant that will be eligible to win the 2019 Chevrolet Trax.

The random drawing for finalists will be supervised by United Way of Anchorage officials whose decisions are final with respect to all matters related to this sweepstakes.

Finalists will be notified in person, by phone, or by e-mail. If United Way of Anchorage is unable to contact a potential finalist, despite reasonable efforts to do so, an alternate finalist will be chosen. If the finalist is not qualified to accept the grand prize, an alternate finalist will be chosen.

Board Members of United Ways in Alaska and their immediate families and other household members and employees of United Ways in Alaska and their immediate families and other household members are not eligible.
